Updating Organization and User Profiles (and Address Changes)

Last Updated: 15 January 2025

1. Has your Business moved? If your business has moved, you must email etg@gov.bc.ca and advise of your new business mailing address. This will help ensure payments are not delayed.
2. Log into the [Skills Training Grants page](#) with your BCeID.
3. If it's your first-time logging into Skills Training Grants, or you haven't logged in for a while, you will need to include some information about your business in the Organization Profile page. **NOTE:** the Organization Profile can be updated by anyone who is listed as a Business Manager on the BCeID account for your organization.
4. Click on the "Organization Profile" Link located on the top right corner of the home page.
